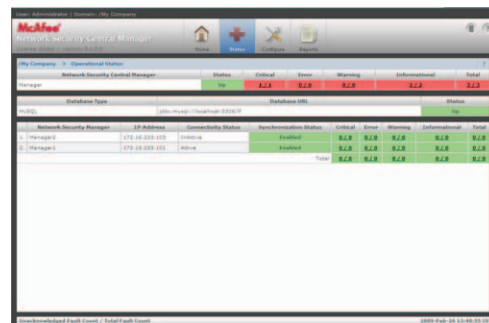

is relieved from the burden of complying with policy updates. Network Security Central Manager automates the process—driving and monitoring policy changes to ensure they take effect.

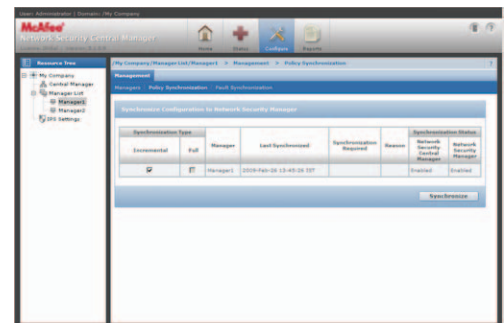
