**Purpose of this Form**

The information provided on this form will be used to determine if an export license from the United States is needed or whether a re-export license from another location is required. Please fill out in English. If it is determined that an export or re-export license is required for the order, then the information below will be used to apply for the license. Once complete send to the appropriate McAfee Order Operations group at the fax or e mail referenced above.

**Who May complete this form**

This form needs to be completed by the End User or an Authorized McAfee Partner. It should be completed by the person most knowledgeable about the order.

**When should this form be Submitted**

This form should be submitted when you first learn the specifics about an order that will require and export or reexport license for a Government End User in order to allow the product to be supported and delivered to the Government End User.

**I. Instructions:**

- A) Only list restricted Hardware and software Products on the application form.
- B) Submissions containing abbreviations, acronyms or a PO box will be considered invalid. Failure to provide complete and accurate information will cause your license application to be rejected.
- C) Please provide all information listed below EXACTLY as it will appear on the purchase document. Any deviation between the purchase document and the license application may result in processing delay and potential resubmission of the license application.
- D) This request to begin a license application may be submitted prior to order receipt provided we are confident that we will get the order. The order must match the license application form 100% or the license when issued can not be used. (i.e. if you do not know the name of the freight forwarder, or distributor, this form can not be completed until all details are known.)
- E) Typical license approval takes 60 to 90 days AFTER all information has been submitted. There is no guarantee that the license will be approved.
- F) The McAfee entity must be listed for all shipments. You must identify the McAfee entity name and address for all licenses. That entity must match the entity which should be on the billing and commercial invoices for any export or re export transaction. No re-export license can be issued to McAfee Inc.
- G) If a website for any party to the transaction is not in English or is not available, please have the party attach documents in English that describe what they do, what are the functions they perform, describe their business, agency, or government function.
- H) McAfee products will not be supported if any product was exported or re-exported in violation of the Export Administration Regulations (EAR).
- I) Licenses may not be amended. No additions or changes are permitted once the application has been submitted to the Bureau of Industry and Security. Ensure that all information entered is complete and accurate. If the Data submitted is not completed or if additional information is required, orders will need to contact the partner or the end user directly which will lengthen the time to process the license application.
- J) No order to Government End User can be exported or reexported until a valid license has been issued
